- <sup>3</sup> Reporting due dates are based on the effective date of your permit. Effective date between January and March: report due February 14. - <sup>5</sup> The final rule revisions published on February 26, 2020 and effective April 10, 2020 limits this reporting requirement to appliances with a full charge of 50 or more pounds of any class I or class II refrigerant or blend containing a class I or class II refrigerant.

<sup>6</sup> "Type A" Title V sources as defined in SC Regulation 61-62.1 Section III(B) have an EI due every year. All other sources have EI's due every 3 years. All are due in 2024. Thus due March 31, 2024 for CY 2023.
