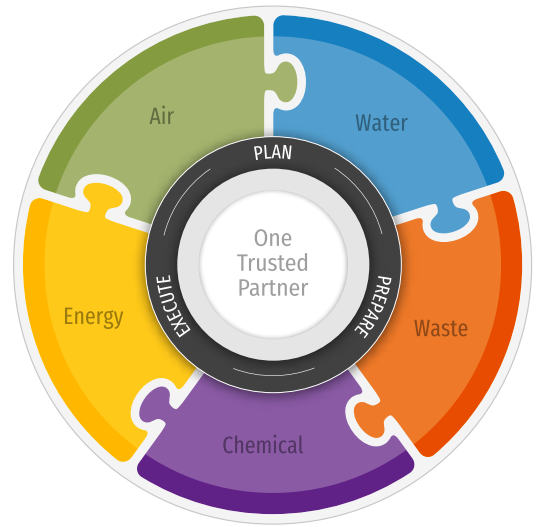

¹ The January 25th deadline for the annual waste summary is for paper filers only. All other waste summaries must be submitted online through STEERS by March 1st. Please note that Large Quantity Generators MUST use STEERS to file their annual waste summary.

² Site and permit specific requirements may vary. Please check individual requirements for reporting deadlines.

³ Title V Semi-Annual and Annual Compliance reporting deadlines are site-specific. MACT compliance reporting deadlines vary by regulation.

⁴ Manufacturers (including importers) are subject to the reporting requirements based on manufacturing (including importing) activities conducted during the calendar years 2020 through 2023.
