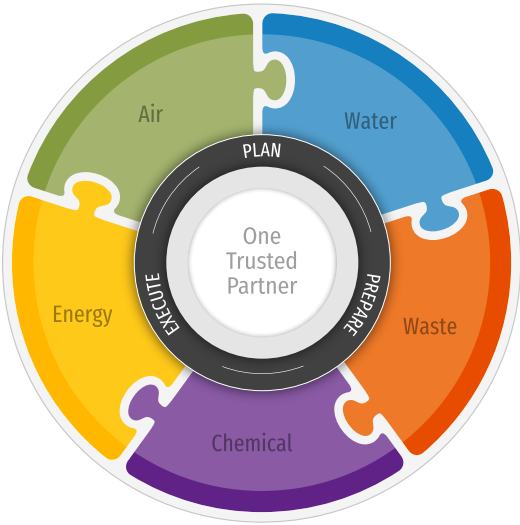

² PFAS reporting under TSCA Section 8(a)(7) covers import and manufacture of PFAS from 2011 to 2022. This is a one-time data gathering and reporting requirement separate from CDR. While similar to CDR in many ways, the PFAS reporting is much more extensive and does not exclude articles, de minimis concentrations, or low levels of activity. The data submission period begins on April 13, 2026, and ends on October 13, 2026, with an alternate end date for small manufacturers reporting exclusively as article importers of April 13, 2027.

³ CDP is a global non-profit that runs the world's only independent environmental disclosure system for companies, capital markets, cities, states and regions to manage their environmental impacts.

⁴ Manufacturers (including importers) are subject to the reporting requirements based on manufacturing (including importing) activities conducted during the reporting period. This report is required every 4 years. The next report will be due in 2028 (covering reporting years for 2024 through 2027).
