² Due every even numbered year. (For example, a report due by March 2024, would be activities from calendar year 2023). This requirement is fulfilled through the Dangerous Waste Annual Report in this state.

³ EPA has proposed moving the 2025 GHGRP deadline to June 10, 2026 and eliminating most reporting requirements after 2024 (with Subpart W suspended until 2034). Until finalized, current March 31 deadlines remain in effect. See details at [Rulemaking Notices for GHG Reporting | US EPA](#).

⁴ Annual emission inventory reporting due dates for local air agencies vary. For example, June 30 for PSCAA and March 15 for SWCAA.

This report is required every 4 years. The last report was due in 2024. The next report will be due in 2028 (covering reporting years for 2024 through 2027).
